### Feather River Land Trust

Feather River Land Trust (FRLT) conserves the magnificent lands and waters of the Feather River region that are globally unique and a source of fresh water for more than 27 million Californians. Founded in 2000 by local residents, FRLT conserves lands most vulnerable to development and degradation—montane meadows and unique wetlands—thus protecting our valuable water resources, biodiversity, and cultural heritage. This area of northeastern California, is more biodiverse than Yellowstone or Yosemite national parks and is important for clean and plentiful water, large natural open spaces where people, plants and wildlife thrive. Together with members, partners, and local communities, FRLT has successfully conserved 70,000 acres of private lands that support outstanding biodiversity, waterways, recreation, working ranches and spectacular scenery. We also run a nationally recognized and replicable outdoor education program for children.

### What is a land trust?

Land trusts are nonprofit organizations working in local communities to conserve natural areas, parks, farmlands, wildlife corridors, and open space for public benefit. These protected lands enhance the local economy, provide educational opportunities, and improve environmental and public health.

**Job Description:** The North Region Land Steward works directly with and is supervised by the North Region Manager to implement land stewardship activities within the Northern Region (American Valley, Indian Valley, Genesee Valley, Lake Almanor Basin, Mountain Meadows Basin) to ensure the conservation of FRLT-owned Preserves and other protected lands. Tasks include mowing and weed-eating, fence construction, supporting the livestock management operation, ecosystem monitoring, operation of game cameras, maintenance of buildings, trail construction, use of hand tools, fire prevention and management, and welcoming of the public while assisting with tours, other outdoor recreation activities, and the study and enjoyment of nature.

**Desired qualities:** Applicants should be passionate about land conservation, well organized, detailed oriented and comfortable working in an outdoor setting. Previous experience with natural resource management, ranch management and construction are preferred but not mandatory.
